Subject: Declaration of Final Result of Combined Graduate Level Examination, 2024 – regarding.

The Commission declared the result of Tier-I of Combined Graduate Level Examination, 2024 on 05.12.2024. Thereafter, Tier-II of the said examination was conducted in the Computer Based Mode on 18.01.2025, 19.01.2025, 20.01.2025 & 31.01.2025.

2. As per Para 16.6 of the Notice of the Examination, based on the aggregate performance in Section-I and Section-II of Paper-I of Tier-II Examination, candidates have been shortlisted for evaluation of Section-III i.e. Computer Knowledge Test (CKT) Module and Data Entry Speed Test (DEST) for all posts except Statistical Investigator (SI) Grade-II. The candidates, who did not qualify in Section-I + Section-II, were not eligible for evaluation of Section-III. The cut-off details and candidates available for all posts except SI Gr. II for further selection process are as follows: -

**In addition to the UR candidates shown above, 2637-SC, 659-ST, 14999-OBC, 6414-EWS, 27-ESM, 82-OH, 6-HH, 40-VH and 9-Pwd-Other candidates qualifying at UR Cut-off at this stage, have been shown under their respective categories.*

3. In accordance with the Notice No. HQ-C11018/1/2024-C-1 dated 22.02.2025 and 27.02.2025 of the Commission, only those candidates who submitted their option cum preference online have been considered for final selection. Therefore, the candidates who submitted their preference online and also qualified in Section-I + Section-II for evaluation of Section-III have been considered for further selection process.

4. As per the Notice of Examination, qualifying in Tier-II, Paper-I, Section-III, Module-I i.e. Computer Knowledge Test (CKT) and Module-II i.e. Data Entry Speed Test (DEST) is essential for qualifying in the final result. Module-I and Module-II are qualifying in nature.

5. As per Para 16.1 and 16.2 of the Notice of the Examination, following are the minimum qualifying marks and maximum percentage of errors: -

a) Minimum qualifying marks in Section-I, Section-II & Module-I of Section-III of Paper-I and Paper-II & Paper-III of Tier-II Examination are as follows

- (i) UR: 30%
- (ii) OBC/ EWS: 25%
- (iii) All other categories: 20%

b) Maximum percentage of errors allowed in Module-II (DEST) of Section-III of Paper-I of Tier-II Examination are as follows

- (i) UR: 20%
- (ii) OBC/ EWS: 25%
- (iii) All other categories: 30%.

8. As per the provisions of the Notice of Examination, allocation of posts to eligible candidates has been made on the basis of merit-cum-preference of posts submitted by the candidates online. Subject to their qualifying in the document verification to be conducted by the respective User Departments, a total of 18,174 candidates have been provisionally recommended for appointment. 11. **Resolution of Tie Cases:** In the event of tie in scores of candidates in Tier-II examination, merit has been decided by applying following criteria, one after another in the given order, till the tie is resolved:

- a) Marks scored in Paper-II of Tier-II Examination for the posts of Junior Statistical Officer (JSO) and Statistical Investigator Gr. II (SI) respectively, if applicable.
 - b) Marks scored in Section-I of Paper-I of Tier-II Examination.
 - c) Date of birth, with older candidate placed higher.
 - d) Alphabetical order in which the names of the candidates appear.
12. The final results of 1267 candidates have been kept withheld due to various reasons as per List-III.
13. 253 rejected/ debarred/cancelled candidates appeared in the Tier II examination. Their result of these candidates has not been processed. The roll no. of these candidates are mentioned in List-IV.
14. Post declaration of the final result of the Examination, further process of Document Verification and appointment formalities will be undertaken by the Allocated Department to the shortlisted candidates. If a candidate does not receive any correspondence from the concerned allocated User Department within a period of six months from declaration of the final result, he/she must communicate immediately thereafter with the concerned User Department. Further, the Commission will not, in any circumstances, entertain any correspondences regarding Document Verification/appointment formalities from the shortlisted candidates.
15. No Reserve List/ Waiting List is prepared by the Commission. Unfilled vacancies in the final result and vacancies arising out of non-joining of shortlisted candidates will be carried forward to the subsequent year(s) by the concerned Departments/ Organisations.
16. Dossiers of the qualified candidates would be compiled electronically by the Commission and will be made available for downloading through e-dossier module on the Commission's website, by the Nodal Officers nominated by the User Departments at the time of vacancy collection of the examination. Dossiers received through any other mode should not be accepted by the user department.
17. User Department(s) are advised to satisfy themselves regarding the eligibility in respect of disability of the PwD candidates.
18. Representations received from the candidates with regard to the Answer Keys of Tier-II Examination have been carefully examined and the Answer Keys have been modified wherever necessary. Final answer keys have been used for evaluation. Final Answer Keys and detailed marks of the selected/ non-selected candidates will be uploaded on the website of the Commission shortly.
