- (iii) Railway Board Secretariat Stenographers Service (M/o Railways)
- (iv) Armed Forces Headquarters Stenographers Service (AFHQ)
- (v) Indian Foreign Service Branch (B) Stenographers (M/o External Affairs)
- (vi) Central Vigilance Commission (CVC)
- (vii) National Technical Research Organisation (NTRO)
