Senior Secretariat Assistant/ Upper Division Clerk Grade Limited Departmental Competitive Examination, 2023 & 2024: Declaration of Final Result for the year 2024 (except Election Commission of India and Central Translation Bureau)

The Commission conducted Paper- I (Computer Based Examination) & Paper –II (Descriptive Examination) of Senior Secretariat Assistant/ Upper Division Clerk Grade Limited Departmental Competitive Examination (LDCE), 2023 & 2024 on 13.05.2024. The above mentioned examination was conducted for the following Services/ Cadres:-

- i. Central Vigilance Commission
- ii. Railway Board Secretariat Clerical Service
- iii. Armed Forces Headquarters Clerical Service
- iv. Election Commission of India
- v. Central Administrative Tribunal
- vi. Central Translation Bureau
- vii. Central Passport Organization, M/o External Affairs
- viii. Soil and Land Use Survey of India, D/o Agriculture and Farmers Welfare
- ix. Forest Survey of India, D/o Environment, Forest & Climate Change
- x. Ministry of Tourism

2. The result of Computed Based Examination (CBE) for Senior Secretariat Assistant/ Upper Division Clerk Grade LDCE, 2023 & 2024 was declared by the Commission on 14.06.2024 wherein 32 candidates qualified for evaluation of Paper–II (Descriptive Exam) for the year 2024. Subsequently, result of Paper – II for short listing of candidates for evaluation of Service Records/ APARs was declared on 19.09.2024 in which 23 candidates were declared qualified for the year 2024.
