Junior Secretariat Assistant/ Lower Division Clerk Grade Limited Departmental Competitive Examination, 2023 & 2024–Declaration of Final Result for the year 2023– reg.

The Commission conducted Paper- I (Descriptive) & Paper –II (Computer Based Examination) of Junior Secretariat Assistant/ Lower Division Clerk Grade Limited Departmental Competitive Examination, 2023 & 2024 on 10.05.2024. The above mentioned examination was conducted for the following Services/ Cadres:-

- i. Railway Board Secretariat Clerical Service, Ministry of Railways;
- ii. M/o External Affairs (Cadre Cell);
- iii. Central Passport Organization, M/o External Affairs;
- iv. Armed Forces Headquarters Clerical Service (AFHQ);
- v. Central Administrative Tribunal;
- vi. Office of the Registrar General, India;

2. The result of Computer Based Examination i.e. Paper-II for Junior Secretariat Assistant/ Lower Division Clerk Grade Limited Departmental Competitive Examination, 2023 & 2024 was declared by the Commission on 29.06.2024 wherein 509 candidates qualified for evaluation of Paper–I (Descriptive Exam) for the year 2023. Subsequently, result of Paper I for short listing of candidates for evaluation of Service Records/ APARs was declared on 08.10.2024 in which 502 candidates were declared qualified for the year 2023.
