**Senior Secretariat Assistant/ Upper Division Clerk Grade Limited Departmental Competitive Examination, 2020, 2021 & 2022: Declaration of result of Computer Based Examination [CBE (Paper- I)] for evaluation of Paper- II (Descriptive Paper) – regarding**

The Commission conducted Paper- I (Computer Based Examination) of Senior Secretariat Assistant/ Upper Division Clerk Grade Limited Departmental Competitive Examination, 2020, 2021 & 2022 on 08.02.2024. The above mentioned examination was conducted for the following Services/ Cadres:-

- a) Railway Board Secretariat Clerical Service
- b) Armed Forces Headquarters Clerical Service
- c) Election Commission of India
- d) Central Administrative Tribunal
- e) Central Translation Bureau
- f) Central Passport Organization, M/o External Affairs
- g) Soil and Land Use Survey of India, D/o Agriculture and Farmers Welfare
- h) Forest Survey of India, D/o Environment, Forest & Climate Change

2. As per the Scheme of the Examination, the examination consisted of two Parts- Part- I comprising of Paper-I (Computer Based Examination) and Paper-II (Written Examination) and Part-II (Evaluation of service records). Only those candidates who qualify in the Computer Based Examination (Paper-I of Part-I) would be considered for evaluation of their Paper-II.

3. Based on the performance in Paper- I of the examination, 325 candidates have been shortlisted for evaluation of Paper -II. The category-wise cut-off marks and the number of candidates qualifying in Paper- I are as given below:-
