Junior Secretariat Assistant/ Lower Division Clerk Grade Limited Departmental Competitive Examination, 2019 & 2020–Declaration of Final Result for the year 2019– reg.

The Commission conducted Paper-I (Descriptive) & Paper-II (Examination Computer Based Examination) of Junior Secretariat Assistant/ Lower Division Clerk Grade Limited Departmental Competitive Examination, 2019 & 2020 on 09.02.2024. The above mentioned examination was conducted for the following Services/ Cadres:-

- i. Railway Board Secretariat Clerical Service, Ministry of Railways;
- ii. Armed Forces Headquarters Clerical Service (AFHQ);
- iii. Central Vigilance Commission;
- iv. M/o External Affairs (Cadre Cell);
- v. Central Passport Organization, M/o External Affairs;
- vi. Central Administrative Tribunal

2. The result of Computed Based Examination for Junior Secretariat Assistant/ Lower Division Clerk Grade Limited Departmental Competitive Examination, 2019 & 2020 was declared by the Commission on 15.03.2024 wherein 165 candidates qualified for evaluation of Paper-I (Descriptive Exam) for the year 2019. Subsequently, result of Paper I for short listing of candidates for evaluation of Service Records/ APARs was declared on 31.05.2024 in which 163 candidates were declared qualified for the year 2019.
