**Senior Secretariat Assistant/ Upper Division Clerk Grade Limited Departmental
Competitive Examination, 2017: Declaration of final result**

The Commission conducted Paper- I (Computer Based Examination) on 28.01.2022 and Paper- II (Written Examination) on 30.01.2022 for Senior Secretariat Assistant/ Upper Division Clerk Grade Limited Departmental Competitive Examination, 2017 wherein 61 candidates appeared in Paper- I and 60 candidates appeared in Paper- II. The above mentioned examination was conducted for making additions to the Select list for Senior Secretariat Assistant/ Upper Division Clerk Grade of the following Services/ Cadres :-

- (i) Central Secretariat Clerical Service;
- (ii) Railway Board Secretariat Clerical Service;
- (iii) Armed Forces Headquarters Clerical Service;
- (iv) Election Commission of India;
- (v) Central Vigilance Commission;
- (vi) Central Administrative Tribunal.

2. Subsequently, the Commission declared the result on 08.01.2024 for evaluation of APARs of candidates who qualified in the Part-I (Paper-I and Paper-II) of the said examination.

5. **Resolution of Tie Cases-**
