Senior Secretariat Assistant/ Upper Division Clerk Grade Limited Departmental Competitive Examination, 2023 & 2024: Declaration of result of Paper-II for evaluation of APARs-regarding

The Commission conducted Paper-I (Computer Based Examination) of Senior Secretariat Assistant/ Upper Division Clerk Grade Limited Departmental Competitive Examination, 2023 & 2024 on 13.05.2024. The above mentioned examination was conducted for the following Services/ Cadres:-

- 1) Central Vigilance Commission
- 2) Railway Board Secretariat Clerical Service
- 3) Armed Forces Headquarters Clerical Service
- 4) Election Commission of India
- 5) Central Administrative Tribunal
- 6) Central Translation Bureau
- 7) Central Passport Organization, M/o External Affairs
- 8) Soil and Land Use Survey of India, D/o Agriculture and Farmers Welfare
- 9) Forest Survey of India, D/o Environment, Forest & Climate Change
- 10) Ministry of Tourism

2. As per the Scheme of the Examination, the examination consisted of two Parts: Part-I comprising of Paper-I (Computer Based Examination) and Paper-II (Written Examination) and Part-II (Evaluation of service records). Scores of Written Examination (Paper-II of Part-I) of only those candidates who qualified in the Computer Based Examination (Paper-I of Part-I) would be considered for short listing the candidates for further evaluation of Service records/ APARs, i.e., Part- II of the examination.

3. Based on the cut-off fixed for Paper-II, the category wise details of candidates provisionally shortlisted for evaluation of APARs are as given below:-
