The Commission conducted Paper- I (Descriptive) & Paper –II (Computer Based Examination) of Junior Secretariat Assistant/ Lower Division Clerk Grade Limited Departmental Competitive Examination, 2021 & 2022 on 04.03.2024. The above mentioned examination was conducted for the following Services/ Cadres:-

- i. Railway Board Secretariat Clerical Service, Ministry of Railways;
- ii. Armed Forces Headquarters Clerical Service (AFHQ);
- iii. M/o External Affairs (Cadre Cell);
- iv. Central Passport Organization, M/o External Affairs;
- v. Farm Machinery Training and Testing Institute, D/o Agriculture and Farmers Welfare;
- vi. Forest Survey of India, M/o Environment, Forest & Climate Change;
- vii. Lal Bahadur Shastri National Academy of Administration;
- viii. Central Administrative Tribunal

2. The result of Computer Based Examination for Junior Secretariat Assistant/ Lower Division Clerk Grade Limited Departmental Competitive Examination, 2021 & 2022 was declared by the Commission 23.04.2024 wherein 569 candidates qualified for evaluation of Paper–I (Descriptive Exam) for the year 2022. Subsequently, result of Paper I for short listing of candidates for evaluation of Service Records/ APARs was declared on 02.07.2024 in which 559 candidates were declared qualified for the year 2022.
